Comments:

- Grading in July done by Wes Finch
- Continue to see potholes due to speed and tree canopy
- Quality is good better shape than it has been for some time

Recommendations:

- Cut overhanging branches overhead to reduce shade
- Proposal hire bucket truck to remove branches
- Continue to do individual pothole repair
- Late fall hire a harley rake to break the surface tension of the road to help grade the road
- Thank you to the Kilpatricks for taking on the expense of 4 Tri-axle loads of 7/8" gravel placed from Dave Hewgill's gate to Jeff Davis's property line.

Snow Removal

- We have used Daryl Beaumont for snow removal for the last 2 years with no complaints
- Daryl has expressed interest again in removing the snow for 2020/2021
- His insurance has increased, therefore our fees have increased
- \$3960 + HST for 25 runs, \$158.40 every run after 25
- Don sourced another price for comparison. Absolute Landscaping quoted \$12 400 per season or \$400 /visit
- Move to have snow removal contract accepted Don Seedman

Road Dues

- Road has been in excellent condition
- Maybe one more tri-axle load by the sign at the beginning of the road?
 - O Don will talk to Finch or Medley about a drop in the fall
- Don added spray paint to the road to mark where the road was Mike Blakely was appreciative so the road doesn't get pushed onto his property. Concern was raised to continue to be sensitive to Mike as a property owner when entering and exiting the road. Thank you to Mike Blakely for maintaining the lawn around our NABRA sign
- Thank you to Dave Hewgill for adding gravel to the road after work was done on his property
- Reminder that the Bell line was added with the trencher approximately 6" deep from the sign to the Hewgill/Davis entrance.
- A poplar was felled from the storm and the tree is still there
 - Should we ask volunteers to help remove it?
 - Most of the tree is on Mike's property he should be asked first

- Poplar tree removal (and associated branches) could be removed when bucket truck is rented. Don will send out an email asking for volunteers when the truck is scheduled
- Reminder to property owners to remove leaves lining the road before grading occurs, if possible.
